## INTRODUCTION

Image Processing and Analysis can be defined as the "act of examining images for the purpose of identifying objects and judging their significance" Image analyst study the remotely sensed data and attempt through logical process in detecting, identifying, classifying, measuring and evaluating the significance of physical and cultural objects, their patterns and spatial relationship.

In a most generalized way, a digital image is an array of numbers depicting spatial distribution of a certain field parameters (such as reflectivity of EM radiation, emissive, temperature or some geophysical or topographical elevation. Digital image consists of discrete picture elements called pixels. Associated with each pixel is a number represented as DN (Digital Number) that depicts the average radiance of relatively small area within a scene. The range of DN values being normally 0 to 255. The size of this area effects the reproduction of details within the scene. As the pixel size is reduced more scene detail is preserved in digital representation.

### PURPOSE:

The purpose of this Report is to provide a detailed overview of our software application, its parameters and goals. This document describes the project's target audience and its user interface, hardware and software requirements.

### Background

With the advent of mobile embedded multimedia devices that are required to perform a range of multimedia tasks, especially image processing tasks, the need to design efficient and high performance image processing systems in a Short time-to-market schedule needs to be addressed. Image Processing algorithms implemented in hardware have emerged as the most viable solution for improving the performance of image processing systems. The introduction of reconfigurable devices and system level hardware programming languages has further accelerated the design of image processing in hardware. Most of the system level hardware programming languages introduced and commonly used in the industry are highly hardware specific and requires intermediate to advance hardware knowledge to design and implement the system. In order to overcome this bottleneck various C-based hardware descriptive languages have been proposed over the past decade. These languages have greatly simplified the task of designing and verifying hardware implementation of the system.

Digital image processing is an ever expanding and dynamic area with applications reaching out into our everyday life such as medicine, space exploration, surveillance, authentication, automated industry inspection and many more areas. Applications such as these involve different processes like image enhancement and object detection. Implementing such applications on a general purpose computer can be easier, but not very time efficient due to additional constraints on memory and other peripheral devices. Application specific hardware implementation offers much greater speed than a software implementation. With advances in the VLSI (Very Large Scale Integrated) technology hardware implementation has become an attractive alternative. Implementing complex computation tasks on hardware and by exploiting parallelism and pipelining in algorithms yield significant reduction in execution times.

There are two types of technologies available for hardware design. Full custom hardware design also called as Application Specific Integrated Circuits (ASIC) and semi custom hardware device, which are programmable devices like Digital signal processors (DSPs) and Field Programmable Gate Arrays (FPGA's). Full custom ASIC design offers highest performance, but the complexity and the cost associated with the design is very high. FPGAs have traditionally been configured by hardware engineers using a Hardware Design Language (HDL).

Image processing is a very highly processor intensive activity. There are thousands of calculations to be completed when filtering an image with a simple 3x3-convolution matrix. There are many commonly available image-processing libraries which implement many of the functions within this project, such as DirectX, WinG and Intel's own Image Processing Library (IPL) which use hardware functions on the Intel CPUs.

This document is intended for professionals or general end pc users having keen interest in image processing and photography, which would like to change certain parameters and composition of their images.

## **2. ELEMENTARY CONCEPTS OF IMAGE PROCESSING**

### **Overview**

Analysis of the image data is done using various image processing techniques and methods that includes:

- ❖ Analog image processing
- ❖ Digital image processing.

Visual or Analog processing techniques is applied to hard copy data such as photographs or printouts. Image analysis in visual techniques adopts certain elements of interpretation, which are as: The use of these fundamental elements of depends not only on the area being studied, but the knowledge of the analyst has of the study area. For example the texture of an object is also very useful in distinguishing objects that may appear the same if the judging solely on tone (i.e., water and tree canopy, may have the same mean brightness values, but their texture is much different. Association is a very powerful image analysis tool when coupled with the general knowledge of the site. Thus we are adept at applying collateral data and personal knowledge to the task of image processing. With the combination of multi-concept of examining remotely sensed data in multi-spectral, multi-temporal, multi-scales and in conjunction with multidisciplinary, allows us to make a verdict not only as to what an object is but also its importance. Apart from this analog image processing techniques also includes optical photogram metric techniques allowing for precise measurement of the height, width, location, etc. of an object.

Digital Image Processing[9] is a collection of techniques for the manipulation of digital images by computers. The raw data received from the imaging sensors on the satellite platforms contains flaws and deficiencies. To overcome these flaws and deficiencies in order to get the originality of the data, it needs to undergo several steps of processing. This will vary from image to image depending on the type of image format, initial condition of the image and the information of interest and the composition of the image scene. Digital Image Processing undergoes three general steps:

- ❖ Pre-processing[9]
- ❖ Display and enhancement[9]
- ❖ Information extraction[9]

Pre-processing consists of those operations that prepare data for subsequent analysis that attempts to correct or compensate for systematic errors. The digital imageries are subjected to several corrections such as geometric, radiometric and atmospheric, though all this correction might not be necessarily is applied in all cases. These errors are systematic and can be removed before they reach the user. The investigator should decide which pre-processing techniques are relevant on the basis of the nature of the information to be extracted from remotely sensed data. After pre-processing is complete, the analyst may use feature extraction to reduce the dimensionality of the data. Thus feature extraction is the process of isolating the most useful components of the data for further study while discarding the less useful aspects (errors, noise etc). Feature extraction reduces the number of variables that must be examined, thereby saving time. Image Enhancement operations are carried out to improve the interpretability of the image by increasing apparent contrast among various features in the scene. The enhancement techniques depend upon two factors mainly as:

- ❖ The digital data (i.e. with spectral bands and resolution)
- ❖ The objectives of interpretation

As an image enhancement technique often drastically alters the original numeric data, it is normally used only for visual (manual) interpretation and not for further numeric analysis. Common enhancements include image reduction, image rectification, and image magnification, transect extraction, contrast adjustments, band rationing, spatial filtering, Fourier transformations, principal component analysis and texture transformation. Information Extraction is the last step toward the final output of the image analysis. After pre-processing and image enhancement the remotely sensed data is subjected to quantitative analysis to assign individual pixels to specific classes. Classification of the image is based on the known and unknown identity to classify the remainder of the image consisting of those pixels of unknown identity. After classification is complete, it is necessary to evaluate its accuracy by comparing the categories on the classified images with the areas of known identity on the ground. The final result of the analysis consists of maps (or images), data and a report. These three components of the result provide the user with full information concerning the source data, the method of analysis and the outcome and its reliability.

### Special Features

#### Filtering

There are two main types of image filtering, linear and non-linear. The method implemented in my project is the linear method, which is achieved by the use of a convolution kernel. Image filtering is generally used to clean up or enhance images, by removing the effects of noise etc. There are many different filters available, from edge detection, enhancement to blur filters and emboss filters etc. Each of the filters are implemented as a convolution mask or convolution kernel.

The above mask is a simple 3x3 mask/kernel, where O9 is the pixel in question. This project will be using different filters from 3x3 kernels (above) to larger kernel such as 9x9 and 11x11.

Most off-the-shelf image packages like Paint Shop Pro does not support the larger masks due to the mass number of calculations required to check/correct each pixel. The larger the mask, the larger the number of calculations and ultimately the longer it takes to filter an image.

**Standard Convolution Algorithm**

The basic operation of a convolution kernel filtering algorithm is based around a kernel or NxN matrix where N is an odd number. The matrix represents the filter coefficients, which will be applied to the image. The matrix is shifted over the image a pixel at a time and the middle value of the matrix is calculated during each iteration. This involves getting the pixel value in the centre of the matrix as well as, in the case of a 3x3 kernel, the values of its eight neighboring pixels. Each pixel is multiplied by its value or weight in the kernel, and then these values are added together. This result is divided by some divisor and finally a biasing factor is added. The final result becomes the new value of the centre pixel, and the matrix slides over to the next pixel and the process is repeated. 3x3 Convolution Kernel Image pixels

The convolution kernel passes across the image from left to right. It then moves down to the new row of pixels and continues till the full image has been processed.

**Common Filters  
Edge Detection**

Psychophysical experiments indicate that a photograph or visual signal with crispier edges is often more subjectively pleasing than an exact photometric reproduction. Edges are not as sharp to the eye. By applying a discrete convolution filter such as one of the following to an image, edge become much clearer.

**Mean Filter**

The average filter is also known as a mean, box or blur filter. The most common use for the average filter is to reduce noise in an image. The averaging filter does exactly as its name suggests, it moves over each pixel in the image and assigns the middle pixel in the kernel the average value of its eight adjacent neighbors. The kernel coefficients can be seen below. There are however a few drawbacks to using this filter. The first being that edges within the image may become blurred because of the changing value regions in that area also if there is a second value (one of the neighbors) which is highly unrepresentative of the area, the average won't be a true average.

**Image Filtering**

Signals that are transferred over almost all forms of communication can be open to noise; an image may be subject to this noise and interference from several sources. These noise effects can be minimized by statistical filtering techniques or by application of spatial adhoc processing techniques.

Image noise arising from noisy sensors or channel transmission errors usually appears as discrete isolated pixel variations that are not spatially correlated. Pixels that are in error often appear markedly different from their neighbors. Many noise-cleaning algorithms make use of this fact.

By examining a pixel and checking to see if the brightness of this pixel is greater then the average brightness of its immediate neighbors by some threshold level, we can see if this pixel is valid or if it may be noise. If the pixel is noise then we replace this pixel with the average of the neighbors. Noisy images have a higher spatial frequency spectrum than normal images. Hence a simple low-pass filter can smoothen out the noise.

**3. TOWARDS THE SOLUTION**

**System Design**

A system design defines the components and the modules of the system and the relationships between them. We identified all the modules in our project and identified the relationships between them. We also determined the flow of data through the whole system and tried to minimize the confusions in it.

**Project Modules**

Here are the detailed description of each and every module of the proposed system.

**Module 1: Image Zooming**

This is a special type of zoom feature which will enable the user, zoom in an image according to his/her choice. In this module, the user will input a numeric value or more specifically, the factor, by which he wants to zoom-in the image. After the image is selected, loaded & displayed onto the screen, the zoom function will be applied on the complete image wherein the height & width of the image will be enlarged or multiplied according to the zoom factor. A notable thing in this function is, if an image is big and/or has a high resolution, large zoom factors would depend upon the system's memory i.e. if we apply a higher zoom factor on an image which is large in size and / or higher in resolution, it will require a large amount of memory to get displayed on the screen. If there is not enough memory in the system, the application would throw a run-time error or an Out-of-memory exception.

**Module 2: Image Auto-Correction**

This feature will enable the user enhance the clarity of a zoomed image. Under this function, once an image is loaded and zoomed according to the user-inputted zoom factor, it will be further clarified or enhanced, which will improve its view ability. When an image is zoomed, every pixel in the image matrix enlarges which results in the pixels being viewed as large squares with boundaries depending upon the zoom factor. Hence, this function will remove the pixel boundaries and will make the entire image smooth thereby improving its clarity.

**Module 3: Image Thresholding**

Thresholding consists of segmenting an image into two regions-A particle region and a background region. In its most simple form, this process works by setting to white all pixels that belong to a gray level interval, called the threshold

interval, and setting all other pixels in the image to black. The resulting image is referred to as binary image. For colour images, three thresholds must be specified, one for each component, ie Red, Green and Blue. In this module , we have implemented the „OTSU“method for performing global thresholding which selects an optimum threshold value based on the spread of pixels, ie variance such that the interclass variance is maximum and intraclass variance is minimum.

#### Module 4: Image Rotation

Rotation performs a geometric transform which maps the position of a pixel in an input image onto a position in an output image by rotating it through a user-specified angle about an origin.

The rotation operator performs a transformation of the form:

$$\begin{aligned}x_2 &= \cos(\alpha) * (x_1 - x_0) + \sin(\alpha) * (y_1 - y_0) + x_0 \\ y_2 &= \sin(\alpha) * (x_1 - x_0) + \cos(\alpha) * (y_1 - y_0) + y_0\end{aligned}$$

where  $(x_0, y_0)$  are the coordinates of the center of rotation (in the input image) and  $\alpha$  is the angle of rotation with clockwise rotations having positive angles.

#### Module 5 : Image Sharpening

Sharpening is one of the most impressive transformations you can apply to an image since it seems to bring out image detail that was not there before. What it actually does, however, is to emphasize edges in the image and make them easier for the eye to pick out -- while the visual effect is to make the image seem sharper, no new details are actually created.

To extract a sharpened view of an image, we smooth this image and then subtract the smoothed result from the original image.

$$g(x, y) = f(x, y) - f_{smooth}(x, y)$$

where ,fsmooth=smoothed version of f(x,y)

Now we are left with only high frequency edge descriptions. we now add some proportion of this gradient image back onto our original image with the high frequency components enhanced. The image has been sharpened according to this formula,

$$f_{sharp}(x, y) = f(x, y) + k * g(x, y)$$

where the scaling constant k is set to 0.7

#### Module 6: Image Smoothing

Through this module, we perform smoothing on the loaded image by applying low pass filter, i.e mean filter.

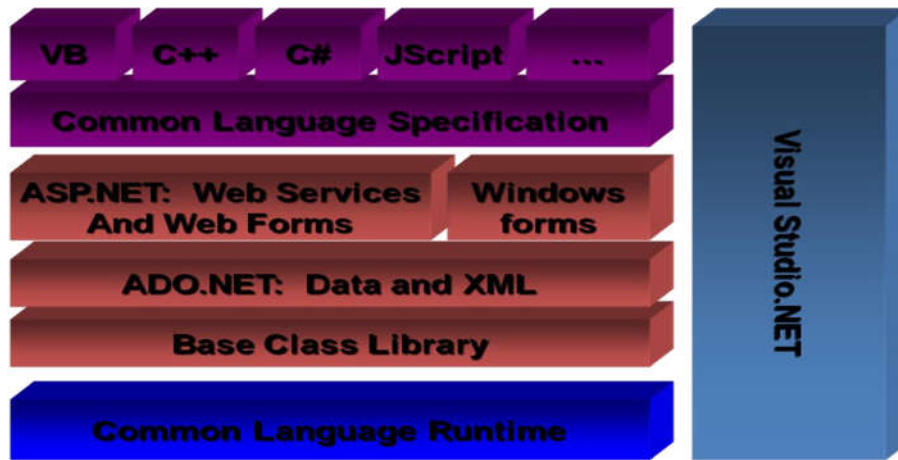

### **C#(.Net):**

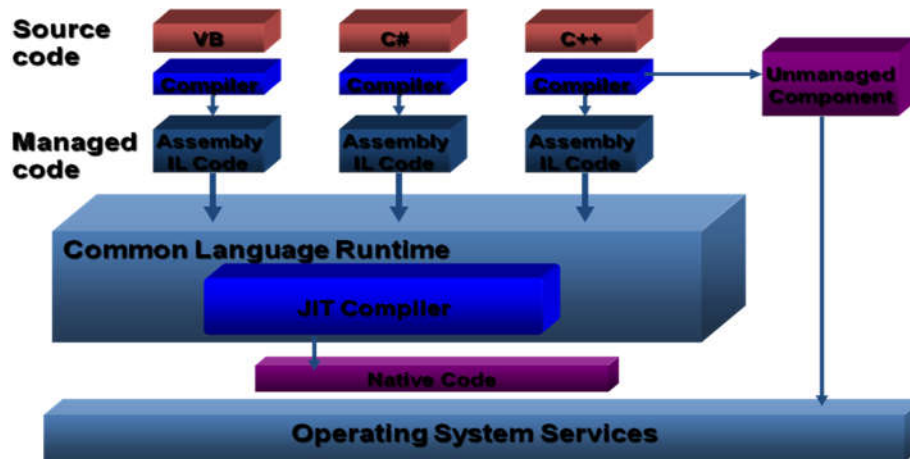

The software cost includes the cost incurred in the purchase of suitable software required for the development of the proposed system like operating system etc.

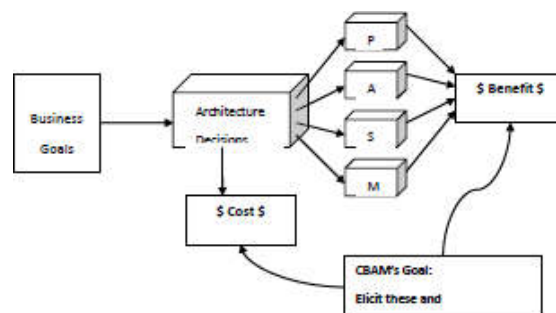


Figure 7 Cost Benefit Analysis
